IPS Officer Nalin Prabhat DG, NSG & Sapna Tewari Spl. Director IB




Nalin Prabhat, a seasoned IPS officer from the 1992 batch in Andhra Pradesh, has been named as the new Director General of the National Security Guard (NSG). NSG, often referred to as the Black Cats, is India's premier counterterrorism unit operating under the Ministry of Home Affairs. Established on October 16, 1984, in the aftermath of Operation Blue Star, its primary mission is to thwart terrorist activities and safeguard states from internal disruptions.

With a focus on counter-terrorism and extensive operational experience, particularly in regions like Jammu and Kashmir, Prabhat's appointment extends until August 2028. Mr. Prabhat belongs to the 1992 batch of IPS officers from the Andhra Pradesh cadre. Presently, he serves as the Additional Director-General of the Central Reserve Police Force (CRPF) stationed in Jammu and Kashmir.

Simultaneously, IPS officer Sapna Tewari, hailing from the 1992-batch of the Odisha cadre, has been appointed as the Special Director of the Intelligence Bureau (IB). The twoyear tenure for Tewari commences upon assuming office or until her retirement on April 30, 2026, in accordance with the DoPT order.

REC okays Rs 1,869 crore loan for Kiru hydro project in J&K



REC Limited, a Maharatna public sector company and a leading NBFC, has signed an agreement with Chenab Valley Power Project Private Limited (CVPPPL) for providing a term loan of Rs 1,869.26 crore. The loan will be utilised for the development, construction and operation of the greenfield Kiru Hydro Electric Project (4×156 MW) on Chenab river located in Kishtwar district of Jammu and Kashmir. Kiru Hydro Electric Project (624 MW), is a run-of-river scheme proposed on Chenab and is about 42 km from Kishtwar. The project envisages the construction of a 135metre-high dam and an underground powerhouse with 4 units of 156 MW each.

The agreement was signed in the presence of CVPPPL Managing Director Ramesh Mukhiya, and Deputy General Manager Rishabh Jain from REC Limited. CVPPPL is a Joint Venture Company between NHPC (51 per cent) and JKSPDC (49 per cent) formed at the initiative of the Jammu and Kashmir government and the Central government to harness the vast hydro potential of Chenab river. The company was incorporated in 2011. CVPPPL has been entrusted with the construction of Kiru HE Project (624 MW), Pakal Dul HE Project (1,000 MW), Kwar HE Project (540 MW), & Kirthai-II HE Project (930 MW) on Build, Own, Operate and Maintain (BOOM) basis with an aggregate installed capacity of 3,094 MW.

SJVN sets milestone with Inauguration of First Multi-purpose Green Hydrogen Pilot Project of the Nation

SJVN Limited has achieved a significant milestone with the inauguration of India's first Multi-purpose (Combined Heat & Power) Green Hydrogen Pilot Project at SJVN's 1,500 MW Nathpa Jhakri Hydro Power Station (NJHPS) in Jhakri, Himachal Pradesh. The green hydrogen produced from the project will be utilized for High Velocity Oxygen Fuel (HVOF) Coating Facility of NJHPS for meeting its combustion fuel requirements. In addition, it will also generate electricity through its fuel cell of 25 kW capacity.

The first Multi-purpose (Combined Heat & Power) Green Hydrogen Generation Plant of the nation has been inaugurated by Chairperson and Managing Director, Smt. Geeta Kapur on April 24, 2024. Speaking about the project, the Chairperson said: "Aligned with National Green Hydrogen Mission of Government of India, SJVN's Green Hydrogen Pilot Project is poised to accelerate the development of green hydrogen production infrastructure in the power sector, thus establishing green hydrogen as a clean energy source." The state-of-the-art Green Hydrogen Pilot Project is set to produce 14 kilograms of Green Hydrogen daily during 8 hours of operation. The hydrogen produced will be stored at a pressure of 30 bars, in six storage tanks, with a total storage capacity of 12 m³. The project will produce hydrogen using alkaline electrolyzer of 20 Nm3/hour capacity, which would be powered by renewable energy supplied from 1.31 MW Solar Power Plant of SJVN in Wadhal, Shimla. Besides generating power, the green hydrogen will also be used for High Velocity Oxygen Fuel Coating of turbine underwater parts. Eating Avocado May Lower Diabetes Risk, Especially for Females



Avocado may be your first choice food at brunch thanks to its creamy texture and documented benefits on heart health. Now, new research has found that this popular food may lower your risk of diabetes. A cross-sectional study published in the Journal of the Academy of Nutrition and Dietetics investigated the relationship between avocado consumption and diabetes in adults.

This study examined a large sample of more than 28,000 adults of varying ages included in the Mexican National Health and Nutrition Survey.

The researchers found that compared to those who did not consume avocados, avocado-consuming females showed a lower risk of diabetes.

Females who ate avocados (30-38 grams/day) had significantly lower odds of diabetes, even after adjusting for various factors such as age, education level, body weight, physical activity, and more. However, while the study revealed a lower risk of diabetes for females who ate avocados, no significant association was observed in males.

Avocados and diabetes risk. What's the link?

Registered dietitian and doctor of public health Wendy Bazilian, who was not involved in the study, said this study has important implications for the population included in it. "Given what we know about the nutritional profile of avocados – they have good unsat-

urated fats, a good source of fiber, and a multitude of vitamins, minerals, and phytonutrients, i'm not surprised to see these findings suggesting that eating avocados may play a role in lower diabetes risk," she said. When it comes to the exact mechanisms at play, Bazilian said avocados offer an "ideal trifecta" for diabetes risk reduction. Firstly, they're rich in fiber. "Eating foods with fiber helps with blood sugar management and satiety," Bazilian ex-

plained. "As fiber makes its way through the digestive system, it slows down digestion which does two things: it makes us feel fuller for longer and also prevents rapid rises in blood glucose after we eat a meal." Both are important for reducing your risk of diabetes. Secondly, avocados are high in unsaturated fat. "Like fiber, fat slows digestion which

can help promote blood sugar management and satiety," Bazilian noted. Another important aspect of the duo of unsaturated fats and fiber is that both these nutrients support heart health. "Diabetes and heart disease are closely linked because their risk factors are similar," Bazilian explained. "Avocados are a heart-healthy food, and the unsaturated fat and fiber found in avocados can help to maintain healthy LDL cholesterol levels, which can help reduce the risk of heart disease."

According to Bazilian, "what's good for the heart is good for diabetes risk, blood sugar, and metabolic function and control." Finally, you might be surprised to learn that avocados are actually fruits. "A healthy eating pattern that is predominantly plant foods, including fruits and vegetables, is associated with a reduced risk of type 2 diabetes and related CVD risk factors," Bazilian pointed out. "It's also important to recognize that, unlike most other fruits, avocados contain no naturally occurring sugars and do not affect the glycemic response," she added." Why avocados may help lower diabetes risk in females and not males Interestingly, while the study found that eating avocados seems to reduce the risk of diabetes for females, no significant observations were shown in males.

Why might that be?

"The researchers point out that the difference in findings in men vs women may be attributed to the different lifestyle factors between men and women," Bazilian noted. "Specifically, more men in the study tended to be smokers (~38%) compared to women (~12%), and smoking can increase the risk of developing diabetes."

Registered dietitian nutritionist Kristen White agreed that differing lifestyle factors could be at play. Additionally, she said it's possible that hormonal differences between males and females could contribute to variations in how avocados affect metabolic health. While this particular finding is intriguing — maybe even confusing — Bazilian said it's

Climbing Stairs May Improve Heart Health and Help You Live Longer



The benefits of exercise are well-known, from better heart health and lower blood pressure to improved mood.

There are many ways to be active on a regular basis, such as taking the stairs. According to the authors of a new study, climbing stairs is associated with improved heart health and longevity.

"One of the main motivators behind this study was that I was often seeing people take the lifts at work rather than taking the stairs — even medical students 10 years younger than myself," Sophie Paddock, MD, of the University of East Anglia and Norfolk and Norwich University Hospital Foundation Trust, in the United Kingdom, told Healthline. "I'd like to think that we can now use the results of this study to encourage people to incorporate more physical activity into their daily lives. We hope that our research will influence policy makers and health care professionals to promote physical activity and stair climbing." The research is being presented at the European Society of Cardiology's Preventive Cardiology conference April 25-27 in Athens, Greece. The study has not yet been published in a peer-reviewed scientific journal.

Climbing stairs promotes heart health, longevity

For this study, researchers conducted a meta-analysis, examining nine studies with 480,479 participants.

Participants included healthy adults ages 35 to 84 and adults with a prior history of heart attack or peripheral arterial disease.

Following the analysis, researchers found that stair climbing was linked to a 24% reduced risk of death from any cause and a 39% lower risk of death from heart disease. Climbing stairs was also associated with a reduced risk of cardiovascular events, such as heart attack, heart failure, and stroke. According to the authors, the next steps for the research will be to objectively evaluate the optimal number of stairs

people should be climbing each day and at what intensity. "The current research is heavily reliant on patients recalling their day-to-day activities, which can lead to bias," Paddock explained.

Regular exercise helps prevent heart disease John Higgins MD, a sports cardiologist at McGovern Medical School

at UTHealth in Houston, not involved in the study, told Healthline exercise strengthens the heart muscle and improves vascular function, among other positive effects, such as:

improved nitric oxide production \cdot improved vascular endothelial function · reduced cardiovascular risk factors

Cardiovascular disease affects the heart and blood vessels. Aerobic exercises such as walking, running, biking, and swimming can help strengthen the heart and improve its ability to function.

"Aerobic exercise can help the heart pump blood more efficiently, reducing the risk of heart failure," Benjamin Boudreaux, PhD, a postdoctoral fellow in Columbia's Center for Behavioral Cardiovascular Health, told Healthline. Boudreaux was not involved in the study.

"Climbing stairs is a form of aerobic exercise, which provides numerous heart health benefits," Boudreaux noted. Regular aerobic exercise helps lower blood pressure over a 24-

hour period, which increases flexibility in the blood vessels and reduces the risk of high blood pressure (hypertension), Boudreaux explained. Exercise also increases levels of "good" HDL cholesterol, he said, which helps reduce "bad" LDL cholesterol and the risk of atherosclerosis, he said.

important to remember that sometimes we can't always explain the results we see in nutrition research. "This is why it's important to both continue doing research and looking at the body of evidence on a topic and what other studies have shown," she said.

Simple ways to include more avocado in your diet

If the findings of this study have inspired you to eat more avocado, Bazilian said there are some swaps you can make that are "very doable."

She believes that slightly less than one serving of avocado per day is a healthy amount that's achievable for most people.

'One way to include more avocado in your diet is to swap mayo or butter on sandwiches with mashed avocado for a creamy, nutrient-rich spread," White suggested. "You could also replace store-bought salad dressings with a homemade avocado dressing. Simply combine avocado, lemon juice, olive oil, and herbs."

Another suggestion?

"Instead of using sour cream or cheese as toppings, use sliced avocado to add creaminess and flavor to tacos, burritos, or salads," White advised. Avocados are also a great addition to smoothies.

"Blend avocado into smoothies for a creamy texture and added nutrients, or use it as a base for desserts like avocado chocolate pudding," White suggested.

In addition, Boudreaux noted that exercise helps regulate blood sugar and improve insulin sensitivity, which helps reduce the risk of type 2 diabetes and related blood vessel damage.

How many stairs should you climb each day?

The new study did not make a specific recommendation for stair climbing frequency.

According to experts interviewed for this article, aiming for three to six flights of stairs per day (assuming each flight is 10 to 15 stairs) is a good goal for overall health.

A 2023 study suggests climbing more than five flights of stairs (or 50 stair steps) daily may reduce the risk of cardiovascular diseases, such as stroke, heart attacks, and blood clots.

'When you increase your heart rate through stair climbing, it helps strengthen the heart muscle and makes it more efficient at pumping blood, so the heart works less now to complete its daily mission of pumping blood packed with nutrients and oxygen throughout your body," Higgins explained.



दुबई में बन रहा दुनिया का लापता मलेशियाई विमान सबसे बड़ा एयरपोर्ट, 35 अरब MH370 का नया VIDEO

डॉलर खर्च करेगा UAE



UAE के दुबई में दुनिया का सबसे बड़ा एयरपोर्ट बनने जा रहा है। इसका नाम अल मखतूम इंटरनेशनल एयरपोर्ट होगा। अल जजीरा के मुताबिक इसे बनाने में 35 अरब डॉलर, यानी करीब 2.92 लाख करोड़ रुपए का खर्च आएगा। UAE के प्रधानमंत्री शेख मोहम्मद बिन राशिद अल मखतूम ने रविवार को सोशल मीडिया पर खुद इसकी जानकारी दी।

उन्होंने बताया कि नया एयरपोर्ट दुबई इंटरनेशनल एयरपोर्ट से 5 गुना बड़ा होगा। हर साल यहां से 26 करोड़ पैसेंजर यात्रा करेंगे। यह प्रोजेक्ट दुबई के अल मखतूम इंटरनेशनल एयरपोर्ट पर शुरू होगा। यहां 5 पैरेलल रनवे होंगे, यानी एक साथ 5 विमान यहां से टेकऑफ या लैंड कर सकेंगे। इसके अलावा एयरपोर्ट पर 400 टर्मिनल गेट होंगे।

10 साल में बनकर तैयार होगा अल मखतूम एयरपोर्ट– प्रधानमंत्री ने बताया कि नए एयरपोर्ट के डिजाइन को मंजूरी दे दी गई है। इस एयरपोर्ट का कुल एरिया 70 स्क्वायर किमी होगा। अगले 10 साल में इसे बनाने का टारगेट रखा गया है। प्रोजेक्ट पूरा होने के बाद दुबई इंटरनेशनल एयरपोर्ट के ऑपरेशन को नए अल मखतूम हवाई अड्डे पर ट्रांसफर कर दिया जाएगा।

इस प्रोजेक्ट के तहत दुबई साउथ में एयरपोर्ट के चारों ओर एक पूरा शहर बसाया जाएगा। इससे 10 लाख लोगों के हाउसिंग प्रोजेक्ट का काम भी पूरा होगा। दुबई एयरपोर्ट इस वक्त दुनिया का सबसे व्यस्त अंतरराष्ट्रीय एयरपोर्ट है। साल 2022 में इस एयरपोर्ट से करीब 6.6 करोड़ यात्री गुजरे थे।

दुबई एयरपोर्ट पर भीड़ को संभालने के लिए फैसला लिया – रिपोर्ट के मुताबिक, कोरोना के बाद यह आंकड़ा घटा है। महामारी से पहले साल 2019 में इस एयरपोर्ट से होकर करीब 8.7 करोड़ लोगों ने यात्रा की थी। वहीं साल 2018 में यहां से 9 करोड़ पैसेंजर्स गुजरे थे। ज्यादा भीड़ की वजह से इस एयरपोर्ट पर कई बार ऑपरेशन संभालने में परेथानियां आती हैं। इसी को देखते हुए अल मखतूम प्रोजेक्ट पर काम किया जा रहा है।

अल जर्जीरा के मुताबिक UAE सालों से दुबई एयरपोर्ट के ऑपरेशन को अल मखतूम एयरपोर्ट पर ट्रांसफर करने की प्लानिंग कर रहा है। हालांकि मंदी की वजह से 2009 में UAE में आई आर्थिक तंगहाली से उबरने की कोशिश में यह टल गया था।

टाइटैनिक जहाज पर सवार रहे सबसे अमीर पैसेंजर की सोने की घड़ी नीलाम हुई है। BBC न्यूज के मुताबिक बिजनेसमैन जॉन जेकब ऐस्टर की यह घड़ी 12 करोड़ से ज्यादा की कीमत पर बिकी है। नीलामी से जुड़े अधिकारी एंड्यू ऐल्ड्रिज ने बताया कि यह वर्ल्ड रिकॉर्ड है।

रिपोर्ट के मुताबिक, इस घड़ी के साथ जॉन के गोल्ड कफलिंक्स भी मौजूद हैं। इसे अमेरिका के एक प्राइवेट कलेक्टर हेनरी ऐल्ड्रिज एंड संस ने खरीदा। इससे पहले टाइटैनिक जहाज के डूबते वक्त घबराए पैसेंजर्स को शांत करने के लिए जो वॉयलिन बजाया गया था, उसे साल 2013 में नीलाम किया गया था। नीलामी शुरू होने के 10 मिनट के अंदर यह वॉयलिन साढ़े 9 करोड़ रुपए में बिका था। 'टाइटैनिक से 2200 लोगों की

मलेशियाई एयरलाइस का लापता विमान MH370 पिछले 10 साल से रहस्य बना हुआ है। विमान को लेकर अक्सर नई थ्योरीज और दावे सामने आते रहते हैं। करीब एक महीने पहले एक्सपर्ट्स ने आशंका जताई थी कि प्लेन के कैप्टन ने विमान को क्रेश करने की योजना बनाई थी। एक्सपर्ट और ब्रिटिश बोइंग 777 के पायलट साइमन हार्डी ने कहा था, 'फ्लाइट MH370 समुद्र की गहराइयों (समुद्र में बनी खाई) में है। कैप्टन जहारी अहमद शाह ने इसे क्रेश करने की प्लानिंग की थी। फ्लाइट के प्री–डिपार्चर डॉक्यूमेंट्स से यह साबित होता है।'

वहीं अमेरिका के टेक्सास राज्य की एक कंपनी ओशन इन्फिनिटी ने दावा किया था कि उनके पास MH370 विमान की क्रैश लोकेशन है। कंपनी ने मलेशियाई सरकार के सामने हिंद महासागर में नए सिरे से खोज शुरू करने का प्रस्ताव भी रखा था।

Malaysia sees promising growth for inbound tourism in 2024

The transformative impact of projects like the Kashi Vishwanath corridor, has revitalized

Varanasi's tourism sector, leading to a substantial increase in tourist footfall and allied economic

activities. The surge in tourism has not only boosted local businesses but also generated substantial revenue for the state. As per the data by the Ministry of Tourism 1,439 million people participated in religious tourism in India during 2022, it is more than double from 677 million in 2021.

In 2022, religious tourism destinations earned Rs1.34 lakh crore in revenue, up from Rs65,070

crore in 2021. In 2022, Varanasi had 82 million visitors, which is almost four times the number of

visitors in 2019. This number accounted for almost 26% of all arrivals in 2022, compared to less

than 4 per cent in 2019. Varanasi's tourist footfall has surpassed Agra, which is home to the Taj

Malaysia's tourism industry is poised for a remarkable rebound, with projections indicating a surpassing of pre-pandemic levels from 2019 and a promising trajectory for future growth, bolstered by strategic collaborations and partnerships within the airline sector.

Malaysia welcomed 20.1 million international tourists in 2023, generating a substantial revenue of 71.3 billion ringgit (US\$14.9 billion). Although this achievement exceeded the Ministry of Tourism, Arts and Culture's target of 16.1 million arriv-

als, it notably fell short of the robust figures seen in 2019, where 26.1 million international tourists contributed 86.1 billion ringgit to the country's economy.

Addressing the APG Network Annual General Meeting 2024, deputy tourism, arts and culture minister Khairul Firdaus Akbar Khan articulated the government's ambitious aspirations, setting a target of 27.3 million tourists and aiming for 102.7 billion ringgit in tourist expenditure for 2024. He stressed the ongoing promotional initiatives and events, particularly highlighting the state-focused campaigns in Melaka, Kelantan, Perak, and Perlis. Expressing optimism, he underscored Malaysia's commitment to surpassing pre-pandemic benchmarks, aligning with the United Nations Sustainable Development Goals. Looking ahead, the government has set its sights even higher, with a tourism target of 31.4 million visitors and revenue of 125.5 billion ringgit slated for 2025. For *Visit Malaysia 2026*, an ambitious goal of attracting 35.6 million tourists is established, with an anticipated tourism revenue of 147.1 billion ringgit.

During his presentation at the event, Shahrin Mokhtar, director, strategic planning at Tourism Malaysia, highlighted the pivotal role of enhanced air connectivity in bolstering international arrivals to Malaysia. He elaborated on the availability of a matching grant designed to incentivise airlines to initiate new services, augment existing frequencies, or introduce charter services to Malaysia. Moreover, Tourism Malaysia is deepening its collaboration with local airlines flying on international routes, with a specific focus on promoting stopover programmes and seamlessly converting transit passengers at Kuala Lumpur International Airport into tourists, thereby harnessing the full tourism potential of the nation.

Japan wants you to spend more with 'luxury tourism'



Japan is gearing up to attract affluent tourists to lesser-known destinations, offering opportunities for an authentic experience of culture, craftsmanship and nature as a record number of foreign travelers come to the country.

The number of inbound travelers surpassed pre-pandemic levels for a sixth consecutive month in March, during which they spent an average of ¥209,000 (\$1,340) per person per stay. Now, the tourism agency wants to get inbound tourists to increase their spending by altering how they travel.

Along with developing resorts, shops, restaurants and a contemporary art museum with Paris' Centre Pompidou, the Royal Commission for AlUla is overseeing tourist-friendly archaeological excavations of colossal

tombs that date to the first century B.C.

And then there's the new Sharaan Nature Reserve, which showcases a repopulated world of rare beasts: the wild goats, known as ibex, with their long horns curving like scimitars; the striking black-and-white oryx antelopes; fleet-footed gazelles; and, one day soon, endangered Arabian leopards. Crown Prince Mohammed bin Salman, who chairs the commission, has camped here for several winters, hosting dignitaries such as US Secretary of State Antony Blinken and Senators Kirsten Gillibrand of New York and Lindsey Graham of South Carolina.

But on this day in March, the weather isn't cooperating for the Wangs. A huge storm brings torrential rain, wind gusts and even hail. At the resort where they're staying, guests' cars are stuck in wet sand. Multitudes of Southeast Asian workers shovel the soaked earth, to little avail. The Wangs are marooned in their hotel until the next day. When the sun reappears, they dig into a bowl of beetroot and feta at an outdoor cafe called the Pink Camel, and all is forgotten. "Stunning view and very friendly people," says Wang's mother, Qiuju, a retired nurse.

The Japan National Tourism Organization (JNTO) aims to increase the number of "luxury tourists" — defined as those who spend more than ¥1 million per person during their stay.

In 2019, this demographic comprised just 1% of overall visitors but they contributed to 14% of total spending. "From the perspective of increasing consumption in rural regions, we want to strategically attract visitors by refining the content we offer and building networks through which we can promote businesses," said JNTO director Rieko Nakayama.

Added Ryo Ito, a JNTO official in charge of the promotion of luxury tourism, "These luxury tourists tend to have high levels of curiosity and are interested in authentic experiences that are unique to specific areas, which goes hand in hand with (our goal of) promoting rural tourism."

"However, there are still some issues that need to be addressed in attracting visitors to these rural areas."
